Pros:

- Here in Finnish Lapland, it has been noticed that they are interested in the IAS
- The limited resources of municipalities
 - encouragement to help with prevention work
 - encourages extermination of species from their "own" areas



Practical tips

- **The municipality should issue a general weeding permit for IAS for their areas**
 - No need to ask permission every time
 - The species can be removed freely
 - Pay attention to the practices and laws of the countries!
- **Waste in the right place** → own place for the waste station, from which proper disposal
- **No new growth sites are created** → waste management company and road maintenance company training if possible?



Invasive alien plant species waste container (IAPS)

- **What:** A waste container where residents can bring AIPS waste for free
- **Here in Lapland there are six municipalities where the containers are in use:** Pello, Kemi, Keminmaa, Tornio, Simo and Muonio
 - Some have only one container and some have more than one (2-4)



How IAPS waste container works?

- KPL association coordinates the waste containers in Lapland → informs municipalities about the purpose and use of containers
- Municipalities decide themselves whether to use the containers or not
 - the municipality acquires the waste container itself and procures the emptying for it
 - KPL association sends the stickers and information signs to the waste container
- Make information signs according to the practices of the countries!
- Place the container in a place with lots of sightings AND/OR somewhere that makes sense logistically
